Water and Sewer collected from the last meeting-\$10,289.00

The two new homes located behind the Vienna Food Mart are ready for water/sewer hookup. Blacktop needs to be completed where the sewer line was installed.

V. OLD BUSINESS

A. ENR Upgrade-Land requisition – the property is owned by DP&. We have reached out to Mike Dietmer to speak with DP&L. We can also consult our



- legal counsel, Pete Golba. The old rail bed is no longer in use. Contact DP&L directly to obtain this property. We need this property for our water/sewer upgrade, or we are going to lose tax revenue.
- **B.** <u>Fireworks-</u>9/20- \$8500.00 in donations have been promised. We currently have \$1150.00 in donations. Donors are requesting a letter with a tax-exempt number. Mayor Travers will meet with the State Fire Marshall, DNR and the Dorchester Sheriff's Department.
- **C.** <u>Gary Bloom Property Mr.</u> Gary Bloom stated that Don Baumgartner, Land Surveyor, presented the final survey plat for his 2,000 sq. home. A letter from the town is needed for the County and State for final approval.

VI. NEW BUSINESS

- **A.** JOB DESCRIPTIONS OF TOWN EMPLOYEE (CODE ENFORCEMENT/Planning & Zoning) There will be a closed door session to discuss the hiring of the code Enforcement Officer/Planning & Zoning Salary for FT/PT job sharing? Candace Donoho will share information that she has for Planning & Zoning.
- B. <u>Greg Koski Development –</u> Greg Koski, Developer, presented his plans for the proposed Gay Street extension and Housing Development. Commissioner Fluharty made the motion to move to the next phase. Commissioner Cusick seconded the motion and Mayor Travers carried the motion to approve.
 - <u>Church Street</u> need R/W for the W/S connection and walking accessibility to be part of the town. Planning & Zoning Committee discussed connecting Church Street.
 - <u>Additional Discussion</u> required to have curb and gutter, infrastructure, planting of trees/shrubs, no parking on the street, garage will be located in back of home, street frontage, etc.
 - <u>Lot Size</u> 9,000 square feet. Commissioner Cusick made the motion. Commissioner Fluharty seconded the motion and Mayor Travers carried the motion.

- **D.** Water & Sewer Operating Deficit Commissioner Fluharty made the motion to raise the water & sewer rates over the next several quarters beginning with the next quarter. We will revisit the rates annually before



we are audited again. \$40.00 per household per year/\$10.00 increase per quarter. We will advertise in The Town Talk, the Post Office and via email. Commissioner Cusick seconded the motion to raise the rates beginning with the September bill. Motion carried.

E. <u>Set Backs –</u> 8 feet. Commissioner Fluharty made the motion to approve. Mayor Travers seconded the motion. Motion carried.

Jamie McFarlane has been trimming trees throughout the town. Tree trimming services are needed and prices/quotes will have to be obtained.
