The Dr. James W. Henry house is one of the prominent mid nineteenth century dwellings to stand on Vienna's Water Street facing the Nanticoke River. Architectural features and chain-of-title research comfortably place construction of this sizable house during the ownership of Dr. James and Anna M. Henry, which stretched from 1851 to 1865. Dr. Henry acquired the Water Street lot from his father-in-law Levin H. Campbell of Talbot County for \$850 in 1851, and at the time the property was improved with a wharf across the street, a store house and a tailor's shop. The well-appointed two-story, side hall/double house, however, was not standing on the property at that time as it was financed by Dr. Henry soon after his purchase. The rear service wing, however, which stands on an off-axis relationship to the main block, may predate the mid century main house, although minimal surviving woodwork inside or out prevents a conclusive estimation of age for this steeply pitched gable roofed structure.

Following purchase in 1851, the property with its finely appointed two-story double-pile house, store, and wharf remained in the hands of James and Anna Henry until after the close of the Civil War when the couple sold the property to Solomon S. LeCompte for \$2,500 in September 1865. The house and the Water Street lot remained under Solomon LeCompte's ownership for only eight years, when after his death, the property was sold in the wake of a Circuit Court case. In July 1873, after five years of court proceedings, the property was transferred by the estate trustee, Clement Sulivane, to Dr. Isaac H. Houston. Dr. Houston is designated at this location on the 1877 Vienna

town map published in the Lake, Griffing, and Stevenson atlas. Following Dr. Houston's purchase, the house and lot remained in family hands until the end of the nineteenth century.

DESCRIPTION SUMMARY

Known variously as the Dr. James W. Henry house, or the Dr. Isaac H. Houston house, or more recently as the Reinhart house, this two-story, three-bay, side hall/double pile frame dwellings stands at 117 Water Street in the town of Vienna, Dorchester County, Maryland. The house is supported by a raised common bond brick foundation and the exterior is sheathed with aluminum siding. The medium pitched gable roof is covered with fiberglass shingles. Built around 1851, the main block is extended to the rear by an off-set single-story gable roofed service wing. While the wing has been remodeled extensively with little interior or exterior architectural fabric evident, its odd positioning to the main block may indicate that it predates the main block. The unusual relationship of the service wing to the main block, standing off axis with the main block, suggests the possibility that it was repositioned on the lot when the side hall/double-pile dwelling was erected at mid century.

GENERAL DESCRIPTION

The Dr. James W. Henry house, also known as the Dr. Isaac H. Houston house, or the Reinhart house, stands at 117 Water Street in the town of Vienna, Dorchester County, Maryland. Built around 1851, the two-story, three-bay, side hall/double-pile main block is supported on common bond brick foundation and the exterior is clad with aluminum siding. The medium pitched gable roof, finished with boxed cornices front and back and flush gable ends, is covered with fiberglass shingles.

The southeast (main) elevation is a three-bay façade with a side entrance and flanking window fitted with six-over-four sash windows. The smaller pane upper sash contrast with the large pane lower sash. A mid nineteenth century front door is topped by a rectangular two-pane transom. Defining the second floor are three six-over-six sash windows. The base of the roof is finished with a boxed cornice.

The southwest gable end elevation is dominated by a pair of exterior, common bond brick stacks distinguished with corbelled shoulders at the second floor level. On the outer side of each stack are multi-pane windows lighting each floor, and a smaller sash window pierces the gable end to light the attic. The end wall of the house is finished flush with a plain bargeboard enclosing the eave.

The northeast gable end is defined by an asymmetrical fenestration with similar windows lighting the first and second floors. There is an exterior brick stove flue that rises against the gable end.

The northwest (rear) wall is partially covered by the single story service wing, which is extended on its southwest side by a shed roofed extension. Fixed in the northwest corner of the main block is an exterior cellar entrance that provides access to an fully excavated cellar.

The interior of the main block features woodwork common to the late second quarter of the nineteenth century with a distinct Greek Revival influence. The staircase is particularly well designed with a turned baluster railing and decorated stringer.

SIGNIFICANCE SUMMARY

The Dr. James W. Henry house is one of the prominent mid nineteenth century dwellings to stand on Vienna's Water Street facing the Nanticoke River. Architectural features and chain-of-title research comfortably place construction of the sizable house during the ownership of Dr. James W. and Anna M. Henry, which stretched from 1851 to 1865.¹ Dr. Henry acquired the Water Street lot from his father-in-law, Levin H. Campbell of Talbot County in 1851 for \$850, and at the time the property was improved with a wharf, store house and a tailor's shop. The well-appointed two-story, side hall/parlor house, however, was not standing on the property at the time as it was financed by Dr. Henry soon after his purchase. Two years later, in June 1853, James W. Henry purchased additional land on each side of Water Street that had been in the estate of Henry Wilcox.² The rear single story wing, which stands off-axis to the main block and was converted to a service wing, likely predates the mid century house. However, minimal evident interior or exterior woodwork prevents a conclusive estimation of age for the rear wing.

HISTORY AND SUPPORT

The two-story frame dwelling, store house, wharf and other improvements remained in the hands of James and Anna Henry until after the close of the Civil War when the couple sold the property to Solomon S. LeCompte in September 1865 for \$2,500.³ The house and Water Street lot remaining in Solomon LeCompte ownership only eight years when, after his death, the property was sold in the wake of a Circuit Court case. In July 1873, after five years of court proceedings, the property was transferred by the estate trustee, Clement Sulivane, to Dr. Isaac H. Houston.⁴ Dr. Houston is designated

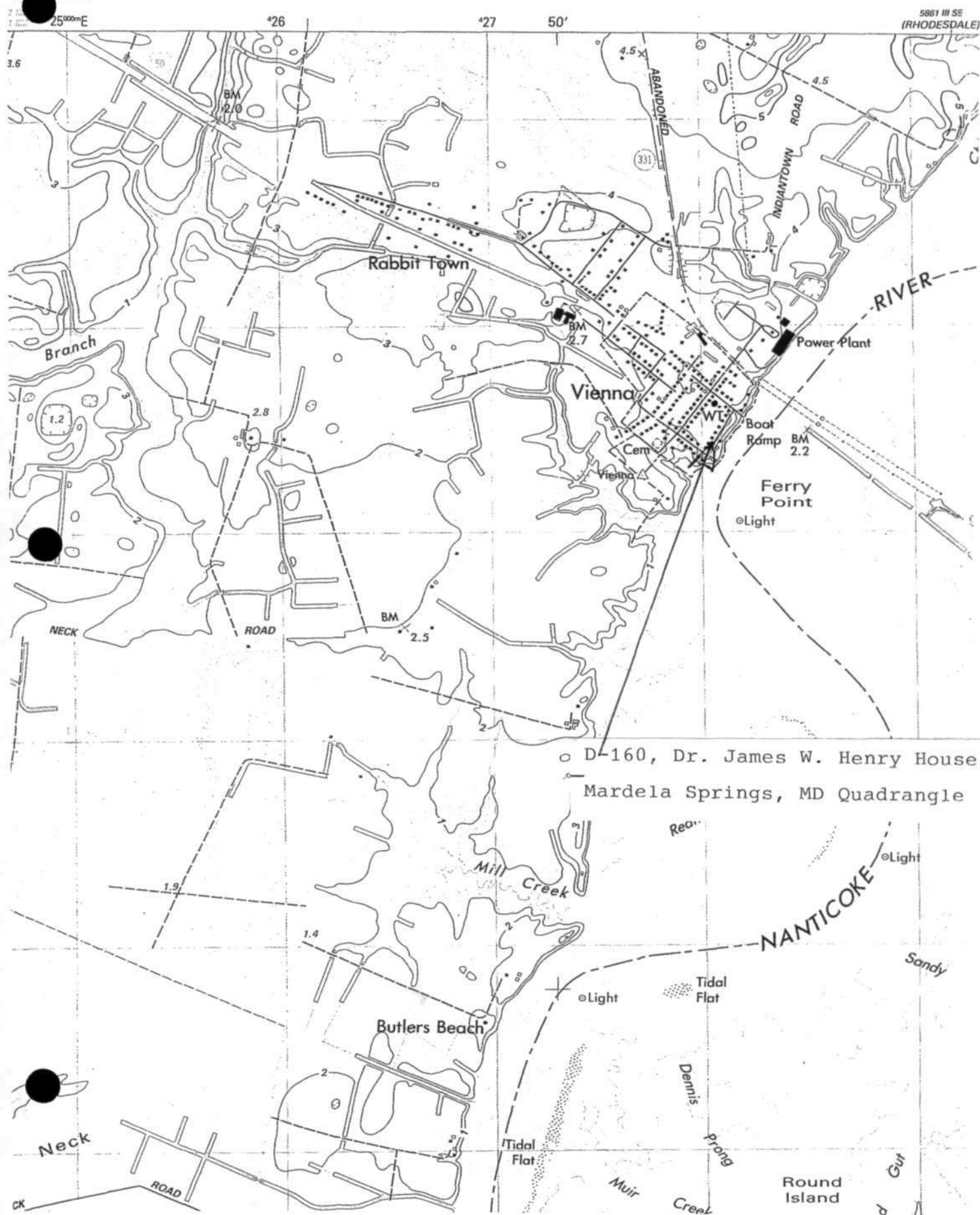

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE			
Built on a high basement, the dwelling is like several on Water Street in Vienna. It has a three-bay, two-story facade with door to one side in the plan of a townhouse. On the opposite gable from the door are double exterior chimneys, the east chimney having its stack removed from the second story up. Typical of the 1830 period is the use of corner blocks in the trim around the entrance door. Its 6/6 sash windows have no shutters and the house is sheathed with white asbestos siding. To the rear and off-set from the front part of the house is a 1½ story kitchen wing which may pre-date the section above. The east windows have 6/4 sash and appear to have been elongated in mid-19th century. At that time it probably has a porch.

Built on a high basement, the dwelling is like several on Water Street in Vienna. It has a three-bay, two-story facade with door to one side in the plan of a townhouse. On the opposite gable are double exterior chimneys, the rear chimney having its stack removed from the second story up. Typical of the 1830 period is the use of corner blocks in the trim around the entrance door. Its 6/6 sash windows have no shutters and the house is sheathed with white asbestos siding. To the rear and off-set from the front part of the house is a $1\frac{1}{2}$ story kitchen wing which may pre-date the section above.

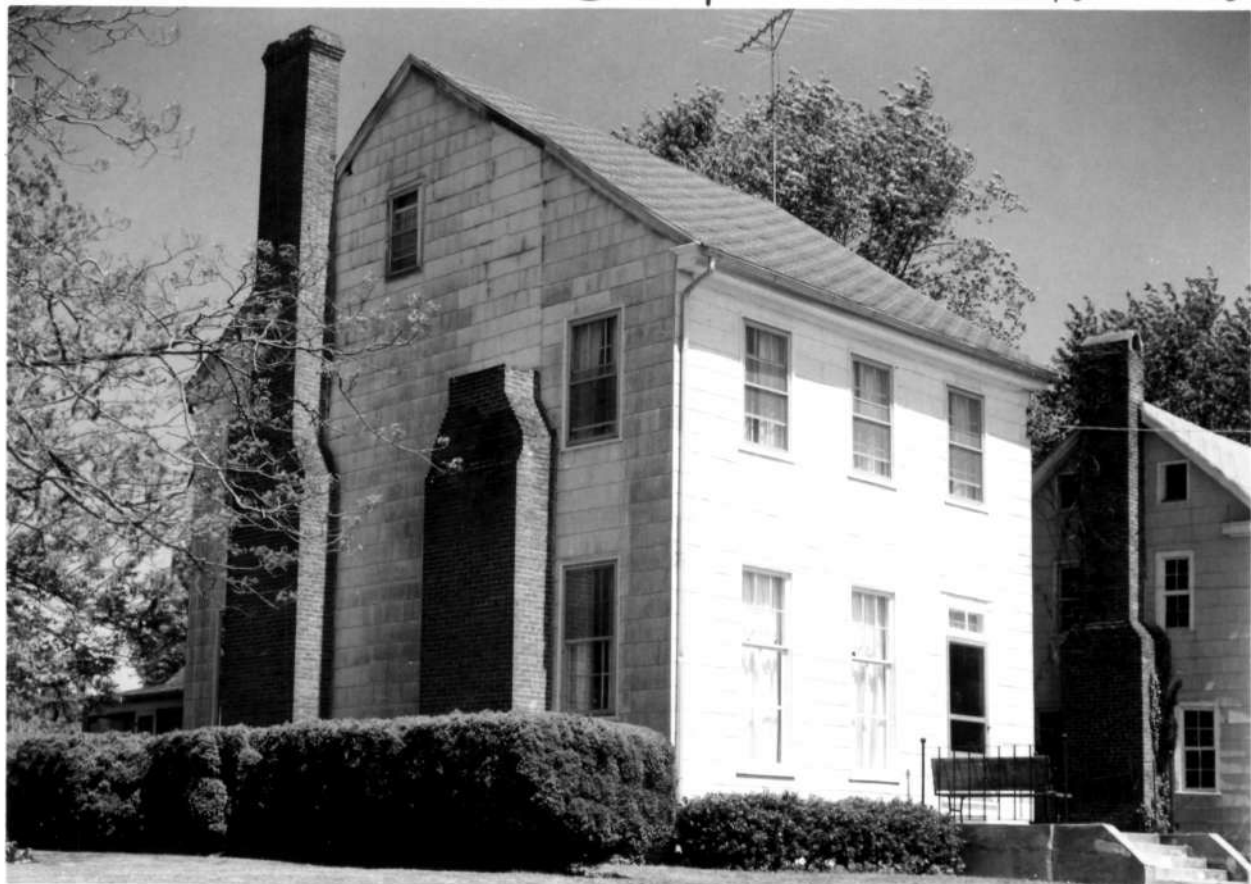
