The Dr. Sylvester Sourin Ewell house is a prominent two-story, side hall/double-pile frame dwelling erected at the intersection of Water and Race streets on the northeast corner of Vienna adjacent to the former location of the Nanticoke River ferry. Built with a dominant gable end pediment reflecting the influence of the Greek Revival style, the wall elevation also features a pair of common bond brick chimneys erected in three-course common bond. While the double-pile main block dates to the third quarter of the nineteenth century, the rear wing is an older early nineteenth century structure that was adapted as a service wing.

Dr. S. S. Ewell was one of two physicians to serve the Vienna community according to the Lake, Griffing, and Stevenson atlas, printed in 1877. Dr. Ewell was listed as a physician and surgeon with an office on Race Street. His practice, which served Dorchester and Wicomico counties, was strategically located in Vienna next to the ferry crossing so that he could quickly answer calls in both counties day and night as advertised in the atlas patron list. Dr. Ewell's ownership of this Nanticoke River property began in 1863 with the purchase of several adjacent lots for \$500. The architectural features of the main block point to its construction by Dr. Ewell shortly after his purchase. The property remained under family ownership until his daughter, Lena E. Nichols sold the property to James A. Higgins in 1909. During the mid to late twentieth century the house and lot were owned by Albert Walter Webb.

DESCRIPTION SUMMARY

The Dr. Sylvester Sourin Ewell house, also known more recently as the Webb House, stands at 3 Water Street facing the Nanticoke River in Vienna, Dorchester County, Maryland. The two-story, three-bay side hall/double-pile plan main block was erected around 1863, whereas a single-story, three-bay rear wing predates the front section by several decades. Supported on a continuous brick foundation, the exterior is clad with vinyl siding, and the medium pitched gable roof is covered with asphalt shingles. Dominating the southwest gable end is a pair of common bond brick chimney stacks. The northwest (rear) wall of the main block is partially covered by the single-story, one-room plan service wing, which has a two-story, one-bay appendage that provides a means of access between the second floor levels of the two sections. The rear wing has been extended in two directions, to the northwest and northeast by 20th century additions. The interior of the main block has been remodeled but it survives with portions of its third quarter of the nineteenth century Greek Revival inspired woodwork.

GENERAL DESCRIPTION

The Dr. Sylvester Sourin Ewell house, also known during the 20th century as the Albert Webb house, stands at 3 Water Street in the river-front town of Vienna in southern Dorchester County, Maryland. The two-story side hall/double-pile dwelling faces southeast with the principal gable roof oriented on a northeast/southwest axis. The main block, infused with Greek Revival stylistic features and finishes, dates to the third quarter of the nineteenth century, whereas the single-story rear wing was erected during the early 19th century. Supported on a continuous brick foundation, the exterior is sheathed with vinyl siding, and the roofs are covered with asphalt shingles. Modern extensions enlarge the rear service wing to the northwest and northeast.

The southeast (main) elevation of the front block is a three-bay elevation with a side entrance and flanking six-over-six sash windows. The partially glazed front door retains lower panels with heavy middle 19th century moldings. The doorway is framed by a cross-muntin transom and three-light sidelights. Sheltering the first floor openings is a single-story hip roofed porch supported by square posts that rest on a new mahogany porch floor. The square posts are replacements of the turned posts and sawn corner brackets that were original to the house. The second story is defined by a set of three regularly spaced six-over-six sash windows, and the base of the roof is finished with a boxed cornice sheathed in vinyl.

The southwest gable end that faces Race Street is dominated by a pair of three-course common bond brick chimney stacks finished with corbelled shoulders at the second floor level beneath a gable end, Greek Revival pediment. Six-over-six sash windows light the first and

second floors, and a replacement window pierces the center of the gable between the two chimney stacks.

The northwest rear elevation is partially covered by the single-story wing that predates the main block by several decades. Built atop the single-story wing against the main block is a two-story appendage that allows for access between the differing floor levels in the two sections. The rear wing is three bays across with an off-center board door and an adjacent six-over-six sash window to the south and a multi-pane fixed window to the north. Attached to the northwest gable end of the service wing is an exterior brick chimney stack covered with stucco. Attached to the northwest and northeast side of the service wing are modern single-story gable roofed or shed roofed additions.

The interior of the main block has been renovated during the early 21st century, but the first floor survives with its original third quarter of the 19th-century staircase, which is anchored by a turned newel mahogany newel post defined by a tapered octagonal shaft. The molded handrail ramps to the second floor landing post. The stringer embellished with a scroll decoration. Access to the space underneath the staircase is provided by means of a four-panel mid 19th century door. The inner hall wall separating the hall from the adjacent parlors has been widened to an extreme, and the lateral partition separating the parlors has been removed which consolidated the two parlors into one space. Remaining on the southwest wall are two third quarter of the 19th-century Greek Revival mantels with scroll supported mantel shelves and segmental arched fireboxes. Included in the renovation were built-in bookshelves and cornice moldings.

The first floor interior of the rear service wing has been remodeled as well but retains its fireplace and a built-in boxed staircase to the right (east) of the fireplace. The fireplace is framed by an early 19th century mantel defined by a raised-panel frieze.

SIGNIFICANCE SUMMARY

The Dr. Sylvester Sourin Ewell house is a prominent two-story, side hall/double pile frame dwelling erected at intersection of Water and Race streets on the northeast corner of the town next to the historic location of the Nanticoke River ferry. Built with a dominant gable end pediment reflecting the influence of the Greek Revival style, the wall elevation also features a pair of common bond brick chimneys erected in three-course common bond. While the double-pile main block dates to the third quarter of the nineteenth century, the rear wing is an older early nineteenth century structure that was adapted as a service wing.

HISTORIC CONTEXT

Dr. S. S. Ewell was one of two physicians who served the community according to the Lake, Griffing, and Stevenson Atlas, which was printed in Philadelphia in 1877.¹ Dr. Ewell was listed as a physician and surgeon, with a practice in Dorchester and Wicomico counties. He had an office on Race Street, and he responded to calls day and night. Dr. Ewell's ownership of this Nanticoke River property began in 1863 with the purchase of several adjacent lots for \$500.² The architectural nature of the main block points to its construction by Dr. Ewell shortly after his purchase. The property remained in family ownership until his daughter, Lena N. Nichols sold the property to James A. Higgins in 1909.³ During the mid 20th century the property was the residence of Albert Walter Webb.⁴

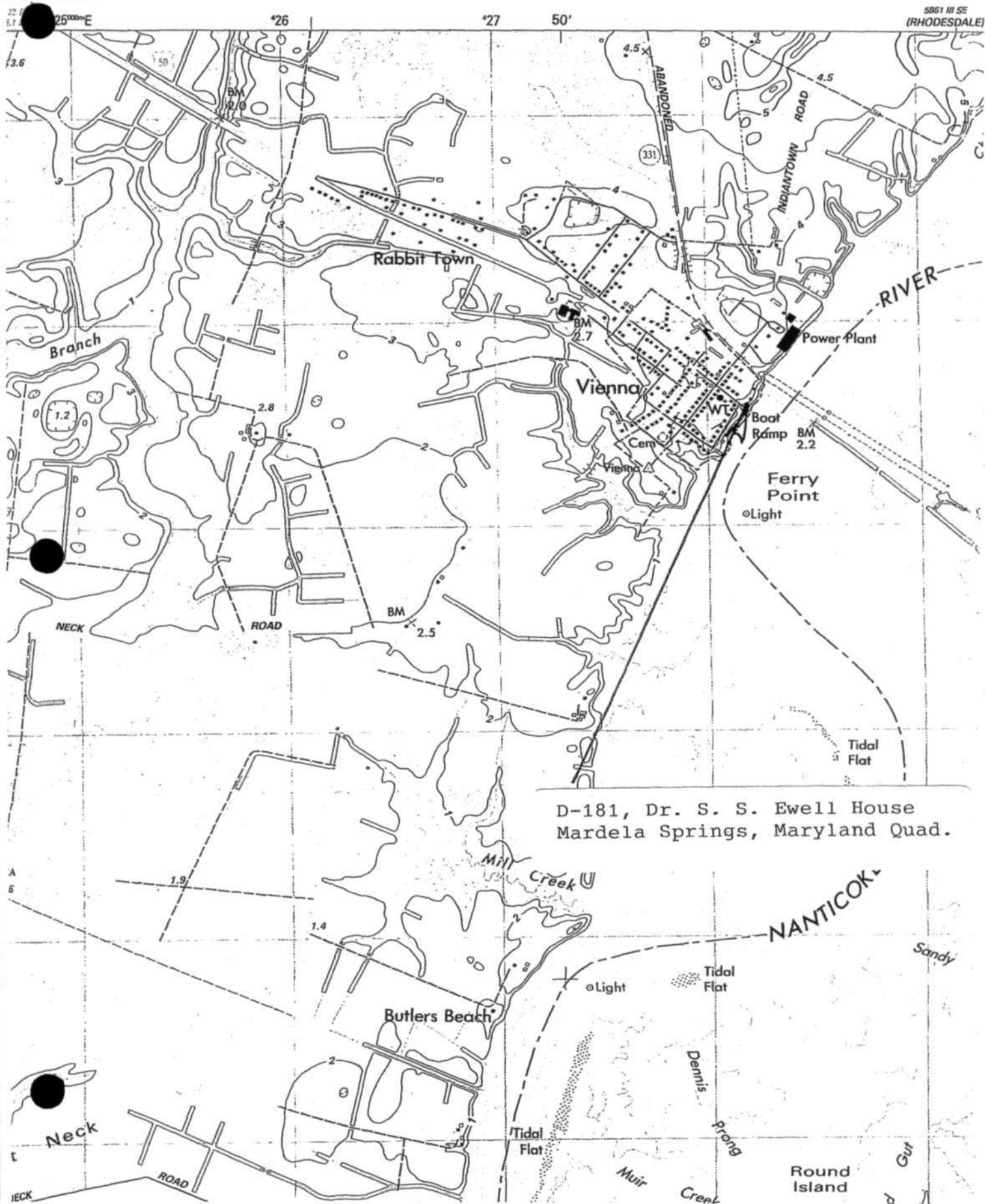

A one-story porch extends across the river facade and partially conceals the door's rectangular transom. To the rear of the house is a two-story kitchen wing.

Another of Vienna's two-story frame town houses facing the Nanticoke River is the Dr. Ewell house located north of Race St. The gable facing Race St has a crude form of pediment interrupted by the two exterior brick chimneys built in English bond. On both stories, the sash is the same: 6/6. A one-story porch extends across the River facade and partially conceals the rectangular transom which has large diamond panes. To the rear of the house is a two-story kitchen wing.
